Policy - external Building Over or Adjacent to a Drainage Easement

Introduction

Purpose

This Policy aims to protect and maintain the functional use of drainage infrastructure from damage during construction works and imposed loads.

Scope

This Policy applies to applicants wishing to build over or adjacent to a drainage easement.

Policy statement

Council will consider the approval of building over or adjacent to drainage easements under the following conditions:

- Structural damage due to construction works or imposed loads are prevented.
- Access for maintenance of Council's assets in drainage easements is available.
- Consequential damage to the land owner's structures is prevented.
- Council's costs and liabilities are minimised when constructing, replacing, maintaining or
 obtaining emergency access to Council owned stormwater infrastructure within private property.
- Amenity (functional use) of land affected by drainage easements is maintained, and allows the occupant to use the land without unnecessary constraints.

Principles

Council's Building Over or Adjacent to a Drainage Easement Guidelines are used when assessing Development Applications including construction on Council's drainage easements.

Objectives

To minimise the risk of avoidable damage to both Council assets and privately-owned infrastructure in or over Council drainage easements.

Review and Evaluation

This policy will be reviewed and evaluated in four years.
